 - o FNU could post video of whole meeting afterward, if desirable

Genesee County Land Bank Authority, Faith Finholm, EPA Funded Commercial & Residential Demolitions

- In 2018, GCLBA applied for/received EPA grant for Flint's "Innovation District" clean-up. The GCLBA is now seeking public comment on properties targeted under the grant.
 - Rough boundaries of the district: Ballenger, Robert T. Longway, Flushing Rd.,
 Center Rd. and I-69
 - Grant is to be used for asbestos and petroleum clean-up, and money must be spent by Aug. 2024

- Looking to clean up 4 commercial properties (1101 S. Dort, 3113 Corunna Rd, 3210 Corunna Rd, 1602 Oren) and a group of 22 residential structures around Chevy Commons/downtown Flint
 - Though this grant can't fund demolitions, the grant can be used for as abate the asbestos in the residential properties which has been an approved use from the EPA
 - Demo of the properties after abatement would be funded through CBGB funding, if secured

 - May extend public comment period 30 days, by request of FNU members; grant money must be spent by August 2024

- In brief update of ARPA-funded demolition project:
 - As of Jan. 5 in the City of Flint: 260 properties abated, 202 knocked down; in the greater county GCLBA has 158 abated and 182 knocked down for <u>a total of 418</u> <u>properties abated and 384 knocked down</u>.
 - A total of 885 projects are contracted or out to bid, to date. (Includes properties already knocked down.)

City of Flint, Entrice "Jiggy" Mitchell, DPW Stormwater Presentation

- Michigan Department of Environment, Great Lakes, and Energy (EGLE) requires the city to monitor and address Flint's storm and sanitary sewer systems
 - Storm and sanitary sewer systems ARE SEPARATE, and things that go into the storm sewer system can and do end up in local creeks, culverts and rivers
 - City of Flint has 350 miles of storm sewers, 7,250 manholes, 14,962 catch basins
 - City has trucks to help clear debris from storm sewers but DPW has just 28 people in this division, so they need support of community to get word out about keeping storm drains clear
 - City has bought 6 new street sweepers and will be conducting regular street sweeping soon; city has been contracting out the service otherwise
 - The City of Flint is working to update its website to make reporting sewer issues easier. To report in the meantime: 810-766-7079
 - Line is monitored 24/7

- DPW is looking for ways to engage with the community on stormwater information. Many FNU members mentioned getting connected to the Flint River Watershed Coalition and Keep Genesee County Beautiful (Green Stormwater Infrastructure Team). Others suggested an incentive program of some sort to support clean-up efforts on the ground.
 - Members also noted pamphlets would also be helpful, especially around oil disposal (where you buy your oil legally needs to take it back) if you do at-home oil changes
 - Neighborhood leaders suggested supporting efforts too, teaming up on clean ups that already exist in their areas

- Jiggy underscored that you should call the City before you call a private company regarding sewer concerns, as you may be charged unnecessarily for that private company's work.
